SECTION A

Decision on Post COVID-19 Teaching and Learning Mode

Question One (50 marks)

The severity of the COVID-19 pandemic has forced institutions around the world to adopt a work-from-home policy. Although life became a bit inconvenient, as the days went by, most people were able to adapt and carry on their required tasks remotely. Academic institutions were not spared the effect of the pandemic, hence, the academic community (a part of which DUT is) also made decisions that impacted the mode of teaching and learning.

However, in 2022, the spread of the virus and the fatality rate has been significantly contained, thanks to the cutting-edge breakthrough in the medical space. Consequently, the university management is tasked with the decision of how academic activities should progress going forward into the new semester.

The choice is whether or not academic activity should be fully remote, full contact, or blended. If blended, in what ratio (e.g. 50%-50%, 60%-40%, 70%-30%, etc.) should it be executed. Regardless of the choice made, there are inherent challenges for stakeholders such as:

- Students
- Lecturers and supervisors
- Administrative staffs
- Technical and support staff
- Department of higher education and training (DHET)
- Learner's sponsor(s) such as family, friends, etc.

As mid-level managers, your team is tasked with making a recommendation to top-level executive managers of the university who will then decide on the best line of action for all stakeholders. The recommendation to be submitted must carefully analyze and take into consideration factors such as (but not limited to):

- Types of qualifications, courses/modules being offered by DUT
- Cost to the university
- Residence provision to students
- Support to staff and students (security, counseling, health...)
- Predisposed health challenges of some staff and students
- The integrity of education and the quality of graduates produced by the university
- The financial and economic standing of students.

Finally, your analysis should take into cognizance the business intelligence reporting tools such as charts and graphs.
